<b>Key elements of the product</b>	Mini-Future Long enable a disproportionate participation in the price development of the Underlying corresponding to the Leverage. Mini-Future Long benefit from rising prices of the Underlying. These Mini-Future Long have no fixed maturity, but have a Stop-Loss Level that is adjusted daily or periodically. Upon reaching the Stop-Loss Level the Mini-Future Long expires immediately and any realisable residual value is repaid to the investor. A daily interest rate consisting of a Money Market Interest Rate and a Financing Spread is offset against the leveraged capital in the amount of the Financing Level provided by the Issuer.
