**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type** This product is a debt security in the form of an uncertificated security issued under Swiss law.

**Term** The product has a fixed term and matures on the Redemption Date.

**Objectives** The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. It allows the investor to receive a cash payment in the Product Currency at least equal to the Capital Protection Amount on the Redemption Date, as well as a participation (see below Upside Participation Rate) in the positive/negative performance of the worst performing Underlying. The redemption of the product depends on the Final Fixing Value of the Underlyings. The redemption modalities are as follows:

- If the Final Fixing Value of the worst performing Underlying at or below its Exercise Price, the investor receives a redemption amount on the Redemption Date that corresponds to the Capital Protection.
- If the Final Fixing Value of the worst performing Underlying is above its Exercise Price, the investor receives a redemption amount on the Redemption Date corresponding to the Denomination multiplied by the Final Fixing Value of the worst performing Underlying divided by its Exercise Price and multiplied by the Upside Participation Rate. I.e. the redemption amount is under-proportionally linked to the positive performance of the Underlying.

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).
