If a Knock-in Event occurs and if the Final Fixing Value of at least one Underlying is below the Cap Level, the investor will receive a physical delivery of a number of Underlyings as defined in Ratio of the Underlying having the largest negative performance. and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this product.

Specific product risks
