You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. The product is primarily aimed at investors who expect a decreasing volatility of the Underlyings and that the value of the Underlyings will be at the same level or above the Cap Level at maturity of the product. The product has a fixed term and matures on the Redemption Date.

By investing in the product, the investor will receive a redemption amount equal to the Denomination on the Redemption Date, provided that the Underlyings perform favourably for the investor. If the Underlyings perform unfavourably for the investor, the redemption amount may be lower. In detail:

- If the Final Fixing Value of **each Underlying is quoted above its Knock-in Level: the product** is repaid in the amount of the Denomination; or
- If the Final Fixing Value of at least one Underlying is at or below its Knock-in Level: the product is repaid at an amount equal to the Denomination multiplied by the Final Fixing Value of the worst-performing Underlying divided by its Cap Level, i.e. the redemption amount is linked to the negative performance of the worst-performing Underlying. In such cases, the redemption amount is usually lower than the amount you invested.

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).

What happens if Zürcher Kantonalbank is unable to pay out?

The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so.
