You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The objective of this product is to offer the investor the prospect of an increased return, accompanied by the risk of a partial or total loss of the capital invested. If the performance of the Underlying is positive, the investor receives a Maximum amount in the product currency. In the event of negative performance of the Underlying, the product is repaid as a cash settlement due to the processing type. The product has a fixed maturity and matures on the Redemption Date. Repayment of the product is dependent on the performance of the Underlying on the Final Fixing Date. The repayment terms are as follows:

- If the Final Fixing Value of the Underlying is below the Cap Level. The product is repaid in the amount of the Denomination plus the maximum possible product performance in the product currency; or
- If the Final Fixing Value of the Underlying is at or above the Cap Level, the redemption amount is equal to the Maximum amount in the alternative currency converted into the product currency at the Final Fixing Value of the Underlying (cash settlement). In this case, a loss may result.

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

What happens if Zürcher Kantonalbank is unable to pay out?
