If the Final Fixing Value is below the Cap Level, the performance is equal to the Maximum Yield (0.737644%). If, on the other hand, the Final Fixing Value is at the same level or above the Cap Level, the performance of the product is inverse to that of the Underlying. The discount reduces the negative performance of the product accordingly.
