**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type** This product is a debt security in the form of an uncertificated security issued under Swiss law.

**Term** The product has a fixed term and matures on the Redemption Date.

**Objectives** The objective of this product is to offer the investor the prospect of an increased return, accompanied by the risk of a partial or total loss of the capital invested. If the performance of the Underlying is positive, the investor receives the Maximum amount in the product currency. The product has a fixed maturity and matures on the Redemption Date.

Repayment of the product is dependent on the performance of the Underlying on the Final Fixing Date. The repayment terms are as follows:

- If the Final Fixing Value of the Underlying is below the Cap Level. The product is repaid in the amount of the Denomination plus the maximum possible product performance in the product currency; or
- If the Final Fixing Value of the Underlying is at or above the Cap Level, the investor will receive the Maximum amount in the alternative currency (see table below). In this case, a loss may result.

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

**Target Market** The product is aimed at Retail investors who are pursuing the objective of general asset accumulation and optimisation and have a very short-term investment horizon. #### What happens if Zürcher Kantonalbank is unable to pay out?

In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. The product manufacturer endeavors to publish bid prices for the product under normal market conditions on each banking day, but is not legally obliged to do so.
