Profit and Loss Expectations at Maturity	ZKB Mini-Futures Long offer the opportunity to benefit disproportionately from a positive performance of the Underlying. The profit outlook is basically unlimited for ZKB Mini-Futures Long. The potential loss of ZKB Mini-Futures Long is limited to the invested capital. ZKB Mini-Futures Long are derivatives whose risk is correspondingly greater than the risk of the Underlying due to the leverage effect. In the event of a Stop-Loss Event, the actual execution price of the closing out of the ZKB Mini-Future Long may diverge sharply from the Current Stop-Loss Level, which is only to be seen as the trigger of a Stop-Loss Event, not as an actual indication of the Redemption Amount of the Product that can be effectively reached.
	3. Material Risks for Investors
Issuer Risk	Obligations under these products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer.
