**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type** This product is a debt security in the form of an uncertificated security issued under Swiss law.

**Term** The product has a fixed term and matures on the Redemption Date.

**Objectives** The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. Due to the Cap Level the redemption amount is limited to the Maximum Redemption Amount. The redemption modalities are as follows:

- If the Final Fixing Value of the Underlying is below the Exercise Price: The redemption of the product takes place via delivery of the Underlying i.e. the redemption is linked to the negative performance of the Underlying. The number of Underlyings to be delivered per Denomination is defined according to the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the sum of the value of the delivered Underlying on the Redemption Date plus the compensation payments (for fractions of the Underlying) is lower than the amount invested by the investor.
- If the Final Fixing Value of the Underlying is at the same level or above the Initial Fixing Value but lower than the Cap Level: The product is redeemed at an amount equal to the Denomination multiplied by the Final Fixing Value divided by the Exercise Price multiplied by the Upside Participation Rate, i.e. the redemption amount is overproportionately linked to the positive performance of the Underlying.
- If the Final Fixing Value of the Underlying is at the same level or above the Cap Level: The product is redeemed at the Maximum Redemption Amount.

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends).

The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so.
