You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. The redemption modalities are as follows:

- If no Knock-Out Event occurs: The product is redeemed at an amount equal to the maximum of the Bonus Payment or the Denomination multiplied by 100.00% of the positive performance of the Underlying (between Initial Fixing Date and Final Fixing Date). I.e. the redemption is proportionately linked to the positive performance of the Underlying. The positive participation is unlimited.

If a Knock Out Event occurs: The product will be redeemed at an amount equal to the Denomination multiplied by 100.00% of the (negative or positive) performance of the Underlying. I.e., the redemption is linked to the performance of the Underlying. In this case, the investor suffers a loss if the redemption amount is lower than the amount invested by the investor.

A Knock-Out Event occurs when the value of the Underlying touches or falls below the Knock-Out Level during the Knock-Out Level Observation Period.

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends).

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

What happens if Zürcher Kantonalbank is unable to pay out?

How long should I hold it and can I take money out early?

Recommended holding period: 15/03/2024 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
