**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type** This product is a debt security in the form of an uncertificated security issued under Swiss law.

**Term** The product has a fixed term and matures on the Redemption Date.

**Objectives** The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. It allows the investor to receive a cash payment in the Product Currency at least equal to the Capital Protection Amount on the Redemption Date, as well as a participation (see below Upside Participation Rate) in the positive performance of the Basket. The redemption of the product depends on the Basket Value on Final Fixing Date. The redemption modalities are as follows:

- If the Basket Value on Final Fixing Date at or below the Exercise Price, the investor receives a redemption amount on the Redemption Date that corresponds to the Capital Protection.
- If the Basket Value on Final Fixing Date is above the Exercise Price, the investor receives a redemption amount on the Redemption Date corresponding to the Denomination multiplied by the Basket Value on Final Fixing Date divided by the Exercise Price and multiplied by the Upside Participation Rate. I.e. the redemption amount is under-proportionally linked to the positive performance of the Underlying.

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).

**Recommended holding period: 19/06/2024 (maturity)** The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive

may be less than the amount you would otherwise have received, even substantially.
