You are about to purchase a product that is not simple and may be difficult to understand.

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant you a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. The product allows you to participate overproportionately (leveraged) in price developments of the Underlying. As a result, you are exposed to a very high risk of a total loss of your invested capital. The product benefits from falling prices of the Underlying as well as from a rising volatility of the Underlying. You have the right to exercise the product daily during the Exercise Deadline (american) and to demand delivery of the corresponding Underlying to the Issuer. The corresponding written exercise notice must be received by the Exercise Agent no later than 12:00 a.m. CET. An exercise notice received later shall be deemed to have been delivered on the next following business day. The product may only be exercised in the Minimum Exercise Quantity, otherwise an exercise is invalid and has no effect

The possibilities for the redemption of the product are as follows:

- If the product is validly exercised within the exercise period, you make delivery of the Underlying to the Issuer five banking days after exercise. In return for this delivery, you will receive from the Issuer an amount equal to the Exercise Price divided by the Ratio.
- If the product is not (validly) exercised but the Final Fixing Value is lower than the Exercise Price, you will receive a cash settlement amount on the Redemption Date, converted where applicable into the product Currency, equal to the difference between the Final Fixing Value and the Exercise Price, divided by the Ratio. #### What happens if Zürcher Kantonalbank is unable to pay out?
