This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. If no Knock-in Event occurs, the investor receives a cash redemption in the amount of the Denomination. The product is considered as transparent and has predominant one-off interest (IUP). The Coupon of 9.20% p.a. is divided into a premium payment of 7.3119% p.a. and an interest payment of 1.8881% p.a..
