If the Final Fixing Value of the Underlying is at or above the Cap Level, the performance of the

Therefore, the investor may suffer a partial or total loss. The acquisition price of the delivered Underlyings is 70.59% of the Initial Fixing Value, which means that the performance of the product is less negative than the performance of the Underlying. This negative performance is reduced by the guaranteed Coupons paid out during the term.
