You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant you a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date, unless a Knock-Out Event occurs. The product allows you to participate overproportionately (leveraged) in price developments of the Underlying. As a result, you are exposed to a very high risk of a total loss of your invested capital. The product benefits from falling prices of the Underlying as well as marginal from a rising volatility of the Underlying.

You have the right to exercise the product on the Expiry Date (european, see Exercise Deadline) and to demand payment of the corresponding redemption amount (as described below) from the Issuer. The product may only be exercised in the Minimum Exercise Quantity, otherwise an exercise is invalid and has no effect. Products, which have not been or have not been validly exercised, are automatically exercised on the Expiry Date without requiring the delivery of an exercise notice by you.

A "Knock-Out Event" occurs if the price of the Underlying touches or exceeds the Knock-Out Price between Initial Fixing Date and Final Fixing Date. In this case, the product expires immediately worthless.

- If a Knock-Out Event did not occur, the possibilities for the redemption of the product are as follows:
- If the product is validly or automatically exercised and theFinal Fixing Value is lower than the Exercise Price, you will receive a cash settlement amount, where applicable converted into the product Currency, equal to the difference between the Final Fixing Value and the Exercise Price, divided by the Ratio. You suffer a loss if the redemption amount is lower than the purchase price of the product.
- If the product is not (validly) exercised and if the Final Fixing Value is equal to or higher than the Exercise Price, the product expires worthless and you do not receive any payments. You suffer a loss in the amount of the purchase price of the product.

You have no entitlements arising from the Underlying and/or Components of the Underlying (e.g. voting rights and dividends).

What happens if Zürcher Kantonalbank is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product - e.g. in the event of insolvency (inability to pay / overindebtedness) or an administrative order of resolution measures. In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. How long should I hold it and can I take money out early?

Recommended holding period: 22/03/2024 (maturity) The Product character does not allow any recommendation regarding the holding period. Due to its Leverage, the Product reacts to the smallest price fluctuations of the Underlying and leads to losses or gains within incalculable periods of time. Any recommendation of a holding period would constitute misleading information for speculative investors. For investors who buy the Product for hedging reasons, the holding period depends on the hedging horizon of the individual investor.
