This product is a combined investment instrument that essentially consists of a fixed income security and the sale of a down-and-in put option. This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. If no Knock-in Event occurs, the investor receives a cash redemption in the amount of the Denomination. If a Knock-in Event occurs, the investor will receive a physical delivery of a number of Underlyings of the Underlying with the worst performance between Initial Fixing Date and Final Fixing Date.
<b>Tax aspects</b>	The product is considered as transparent and has no predominant one-off interest (Non-IUP). The Coupon of 10.976% p.a. is divided into a premium payment of 9.7089% p.a. and an interest payment of 1.2671% p.a..
