Key elements of the product The investor benefits both from a rising Underlying and from the rising volatility of the

Underlying. The investor has the right (not the obligation) to demand a cash settlement amount equal to the difference between the price of the Underlying on the Expiry Date (european) and the Exercise Price (taking into account the Ratio). Knock-Out Warrants are suitable for investors with a high risk tolerance who invest the Issue Price in order to speculate on the future performance of the Underlying or to hedge a portfolio against market fluctuations. The potential return from the investment amount is overproportionately higher

than a direct investment in the Underlying due to the Leverage effect. Knock-Out Warrants basically function in the same way as conventional warrants, but if the Underlying touches or

falls below the Knock-Out Price during the term, they expire worthless.

### 2. Profit and Loss Expectations at Maturity

Warrants offer the opportunity to generate profits through price changes in the Underlying via a Leverage effect. The profit potential for Call Warrants is basically unlimited. The loss potential is limited to the capital invested. Due to the Leverage effect, the value of a Warrant changes more strongly than the value of the Underlying. The value of a Call Warrant generally decreases if the price of the Underlying decreases. The value of a Warrant may also decrease if the price of the Underlying remains unchanged because the time value and/or volatility decreases or supply and demand develop unfavorably.

#### 3. Material Risks for Investors

**Issuer Risk** 

Obligations under these products constitute direct, unconditional and unsecured obligations

of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the product not only depends on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this product.

Warrants involve the risk of losing the initial capital paid (Issue Price) altogether. They are intended only for experienced investors who understand and are able to bear the associated risks. #### 4. Additional Terms
