Key elements of the product The investor benefits both from a falling Underlying and from the rising volatility of the Underlying. The investor has the right (not the obligation) to demand a cash settlement amount equal to the difference between the price of the Underlying on the Expiry Date or Exercise Date (american) and the Exercise Price (taking into account the Ratio). The profit potential for Put Warrants is limited and is reached when the price of the Underlying falls to zero. The loss potential is limited to the capital invested. Due to the Leverage effect, the value of a warrant changes more than the value of the Underlying. The value of a Put Warrant generally decreases when the price of the Underlying increases. The value of a warrant may also decrease if the price of the Underlying remains unchanged because the time value and/or volatility decreases or supply and demand develop unfavorably.
Issuer Risk	3. Material Risks for Investors Obligations under these products constitute direct, unconditional and unsecured obligations of the Issuer and rank pari passu with other direct, unconditional and unsecured obligations of the Issuer. The value of the product not only depends on the performance of the Underlying and other developments in the financial markets, but also on the solvency of the Issuer, which may change during the term of this product.

take all the necessary actions and, if necessary may modify the terms and conditions of these products at its own discretion in such way, that the economic value of the products after occurrence of the extraordinary event corresponds, to the extent possible, to the economic value of the products prior to the occurrence of the extraordinary event.

Change of Obligor
