# You are about to purchase a product that is not simple and may be difficult to understand.

### What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant you a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. The product allows you to participate overproportionately (leveraged) in price developments of the Underlying. As a result, you are exposed to a very high risk of a total loss of your invested capital. The product benefits from falling prices of the Underlying as well as from a rising volatility of the Underlying. You have the right to exercise the product daily during the Exercise Deadline (american) and to demand payment of the corresponding redemption amount (as described below) from the Issuer. The product may only be exercised in the Minimum Exercise Quantity, otherwise an exercise is invalid and has no effect. Products, which have not been or have not been validly exercised, are automatically exercised on the Expiry Date without requiring the delivery of an exercise house. #### What happens if Zürcher Kantonalbank is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / overindebtedness) or an administrative order of resolution measures. #### How long should I hold it and can I take money out early?

Recommended holding period: 27/01/2025 (maturity) The Product character does not allow any recommendation regarding the holding period. Due to its Leverage, the Product reacts to the smallest price fluctuations of the Underlying and leads to losses or gains within incalculable periods of time.
