You are about to purchase a product that is not simple and may be difficult to understand.

#### What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Objectives The objective of this Product is to provide the Investor with an entitlement to returns in the form of a Coupon Payment which is independent of the performance of the Underlying (the "Underlying", see table below). The Coupon Payment is equal to 9.0884% p.a. of the Denomination and is payable on the Coupon Date.

#### Repayment on maturity

If the investor holds the product until the repayment date, the maximum amount it may receive is the repayment amount plus the sum of the coupon amounts. The investor does not participate in the positive performance of the underlying.

By investing in the product, the investor will receive a repayment amount equal to the Denomination on the repayment date, provided that the underlying performs favourably for the investor. If the underlying performs unfavourably for the investor, the repayment amount may be lower. In detail:

- If the final fixing value of the underlying is quoted above the knock-in level: the product is repaid in the amount of the nominal value; or
- If the final fixing value of the underlying is at or below the knock-in level: the product is repaid by delivery of the underlying, i.e. the repayment is linked to the negative performance of the underlying. The number of underlyings to be delivered per nominal amount is determined according to the Ratio on the final fixing date. Remaining fractions are not delivered but settled in cash. In such cases, the repayment amount is usually lower than the amount you invested.
