You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. It allows the investor to receive a cash payment in the Product Currency at least equal to the Capital Protection Amount on the Redemption Date, as well as a participation (see below Upside Participation Rate) in the positive/negative performance of the worst performing Underlying. In addition, the investor is entitled to returns in the form of a Coupon Payment which is independent of the performance of the Underlyings. The Coupon Payment is 0.20% p.a. of Denomination and is payable on the respective Coupon Payment Date. The positive participation is non limited. The redemption of the product depends on the Final Fixing Value of the Underlyings. The redemption modalities are as follows:

- If the Final Fixing Value of the worst performing Underlying at or below its Exercise Price, the investor receives a redemption amount on the Redemption Date that corresponds to the Capital Protection.
- If the Final Fixing Value of the worst performing Underlying is above its Exercise Price, the investor receives a redemption amount on the Redemption Date corresponding to the Denomination multiplied by the Final Fixing Value of the worst performing Underlying divided by its Exercise Price and multiplied by the Upside Participation Rate. I.e. the redemption amount is under-proportionally linked to the positive performance of the Underlying.

The product is currency hedged, i.e. the calculation of the repayment does not depend on exchange rate fluctuations between the product currency and the currency of the underlying (quanto style).

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

The risk indicator assumes you keep the product until maturity. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. We have classified this product in the risk class 2 on a scale of 1 to 7, where 2 corresponds to risk class a low. Recommended holding period: 27/07/2027 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The product manufacturer endeavors to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally obliged to do so.
