You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. It allows the investor to receive a cash payment in the Product Currency at least equal to the Capital Protection Amount on the Redemption Date, as well as a participation (see below Upside Participation Rate) in the positivenegative performance of the Underlying. The redemption of the product depends on the Final Fixing Value of the Underlying. The redemption modalities are as follows:

- If the Final Fixing Value at or below the Exercise Price, the investor receives a redemption amount on the Redemption Date that corresponds to the Capital Protection.
- If the Final Fixing Value is above the Exercise Price, the investor receives a redemption amount on the Redemption Date corresponding to the Denomination multiplied by the Final Fixing Value divided by the Exercise Price and multiplied by the Upside Participation Rate. I.e. the redemption amount is proportionally linked to the positive performance of the Underlying.

The product is currency hedged, i.e. the calculation of the repayment does not depend on exchange rate fluctuations between the product currency and the currency of the underlying (quanto style).

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends).
