You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. The redemption modalities are as follows:

- If no Knock-Out Event occurs: The product is redeemed at an amount equal to the maximum of the Bonus Payment or the Denomination multiplied by 100.00% of the positive performance of the Underlying having the worst performance (between Initial Fixing Date and Final Fixing Date). I.e. the redemption is proportionately linked to the positive performance of the worst performing Underlying. The positive participation is unlimited.
- If a Knock-Out Event occurs: The redemption of the product is effected by delivery of the Basket, i.e. the redemption is linked to the performance of the Basket. The number of Underlyings to be delivered is defined according to the Ratio (fractions will be paid in cash, no cumulation). In this case, the investor will incur a loss, if the value of the delivered Underlyings on Redemption Date plus the compensation payments (for fractions of the Underlying) is lower than the amount invested by the investor.

A Knock-Out Event occurs when the value of the weighted Basket touches or falls below the Knock-Out Level during the Knock-Out Level Observation Period.

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

What happens if Zürcher Kantonalbank is unable to pay out?

The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
