You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. Due to the Cap Level the redemption amount is limited to the Maximum Redemption Amount. The redemption modalities are as follows:

- If the Basket Value on Final Fixing Date is below the Exercise Price: The product is redeemed at an amount equal to the Denomination multiplied by the Basket Value on Final Fixing Date divided by the Exercise Price multiplied by the Downside Participation Rate, i.e. the redemption amount is linked to the negative performance of the Basket. In such a case, the investor suffers a loss if the redemption amount is lower than the amount he invested.
- If the Basket Value on Final Fixing Date is at the same level or above the Exercise Price but lower than the Cap Level: The Product will be redeemed at an amount equal to the Denomination multiplied by the Basket Value on Final Fixing Date divided by the Exercise Price multiplied by the Upside Participation Rate, i.e. the redemption amount is overproportionately linked to the positive performance of the Basket.
- If the Basket Value on Final Fixing Date is at the same level or above the Cap Level: The product is redeemed at the Maximum Redemption Amount.

What happens if Zürcher Kantonalbank is unable to pay out?
