You are about to purchase a product that is not simple and may be difficult to understand.

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. The product is primarily aimed at investors who expect a decreasing volatility of the Underlying and that the value of the Underlying will be at the same level or above the Cap Level at maturity of the product. The product has a fixed term and matures on the Redemption Date. The redemption of the product depends on the Final Fixing Value of the Underlying. The Redemption Method is as follows.

- If the price of the Underlying is quoted above the Knock-in Level at any time during the Knock-in Level Observation Period: the product is repaid in the amount of the Denomination
- If the price of the Underlying is quoted at or below the Knock-in Level at any time during the Knock-in Level Observation Period and
 - if the Final Fixing Value of the Underlying is at or above the Cap Level: the product is repaid in the amount of the Denomination; or
 - if the Final Fixing Value of the Underlying is below the Cap Level: the product is repaid by delivery of the Underlying, i.e. the repayment is linked to the negative performance of the Underlying. The number of Underlyings to be delivered per Denomination is defined according to the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the sum of the value of the delivered Underlying on the Redemption Date plus the compensation payments (for fractions of the Underlying) is lower than the amount invested by the investor.

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends). The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

What happens if Zürcher Kantonalbank is unable to pay out?
