You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The objective of this product is to give you the option of participating indefinitely in the positive performance of the underlying components of a basket ("ZKB Tracker Certificate on Global Small & Mid Caps" – the "Underlying", see below), less certain fees and costs (as specified below). The product has a fixed maturity until 12. December 2025. The product replicates the performance of the Underlying, taking into account the weighting of the individual underlying components contained therein, and is therefore comparable to a direct investment in the underlying components in terms of risk. By investing in this product, investors expect an uptrend in the underlying components. Depending on price development, the price of the product may be higher or lower than the Issue price (as defined below).

What happens if Zürcher Kantonalbank is unable to pay out?

In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. How long should I hold it and can I take money out early?

Recommended holding period: 12/12/2025 (maturity) This product is designed to be invested until the maturity date 12/12/2025. The product does not grant the investor any early right of return. For that reason, investors must be prepared to remain invested for the recommended holding period.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
