If the Final Fixing Value is above the Cap Level, the performance is equal to the Maximum Yield (0.408333%). If, on the other hand, the Final Fixing Value is at the same level or below the Cap Level, the performance of the product follows that of the Underlying. The discount reduces the negative performance of the product accordingly.

## 3. Material Risks for Investors
