You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. The product is primarily aimed at investors who expect a decreasing volatility of the Underlying and that the value of the Underlying will be at the same level or above the Cap Level at maturity of the product. The product has a fixed term and matures on the Redemption Date.

The redemption of the product depends on the Final Fixing Value of the Underlying. The Redemption Method is as follows.

- If the Final Fixing Value of the Underlying is at or above the Cap Level, the investor will receive a redemption amount equal to the Denomination on the Redemption Date.
- If the Final Fixing Value of the Underlying is below the Cap Level, the product is redeemed by delivery of the Underlying taking into account the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the sum of the value of the delivered Underlying on the Redemption Date plus the compensation payments (for fractions of the Underlying) is lower than the amount invested by him.

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends).

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

What happens if Zürcher Kantonalbank is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. How long should I hold it and can I take money out early?

Recommended holding period: 10/02/2025 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
