You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. It is primarily aimed at investors who expect a decreasing volatility of the Underlyings and expect the value of the product at maturity will be at the same level or above the respective Cap Level. The investor purchases the product at a discount and does not benefit if the closing price of the Underlyings is above the corresponding Cap Level .

The amount of the repayment depends on the performance of the Underlyings on the Final Fixing Date. In detail:

- If no Knock-in Event occurs: The product is repaid in the amount of the Denomination; or
- If a Knock-in Event occurs and
 - if the Final Fixing Value of each Underlying is at or above its Cap Level: The product is repaid in the amount of the Denomination; or
 if the Final Fixing Value of at least one Underlying is below its Cap Level: The product is repaid by delivering the Underlying with the worst performance (between the Initial Fixing Date and the Final Fixing Date), i.e. the redemption amount is linked to the negative performance of the Underlying with the worst performance. The number of Underlyings to be delivered per Denomination is defined according to the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the value of the delivered Underlying on the Redemption Date, including the compensation payments (for fractions of the Underlying), is lower than the amount invested by the investor.

A Knock-in Event occurs when the value of at least one Underlying touches or falls below the Knock-in Level during the Knock-in Level Observation Period. The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends). The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

What happens if Zürcher Kantonalbank is unable to pay out?

Recommended holding period: 31/10/2025 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so.
