The profit potential for Put Warrants is limited and is reached when the price of the Underlying falls to zero. The loss potential is limited to the capital invested. Due to the Leverage effect, the value of a warrant changes more than the value of the Underlying. The value of a Put Warrant generally decreases when the price of the Underlying increases. The value of a warrant may also decrease if the price of the Underlying remains unchanged because the time value and/or volatility decreases or supply and demand develop unfavorably.</p>

Warrants do not yield any current income. If there is no fall in the price of the Underlying and/or increase in volatility, a Put Warrant generally loses value and may expire worthless at maturity. The maximum risk is therefore the loss of the capital invested.

4. Additional Terms

Modifications

If an extraordinary event as described in the Base Prospectus occurs in relation to an Underlying/Component of the Underlying or if any other extraordinary event occurs, which makes it impossible or particularly cumbersome for the Issuer, to fulfill its obligations under the products or to calculate the value of the products, the Issuer shall at its own discretion take all the necessary actions and, if necessary may modify the terms and conditions of these products at its own discretion in such way, that the economic value of the products after occurrence of the extraordinary event corresponds, to the extent possible, to the economic value of the products prior to the occurrence of the extraordinary event.

Change of Obligor
