You are about to purchase a product that is not simple and may be difficult to understand.

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The objective of this Product is to provide the Investor with an entitlement to returns in the form of a Coupon Payment which is independent of the performance of the Underlying (the "Underlying", see table below). The Coupon Payment is equal to 6.00% p.a. of the Denomination and is payable on the

#### Repayment on maturity

If the investor holds the product until the Redemption Date, the maximum amount it may receive is the redemption amount plus the sum of the coupon amounts. The investor does not participate in the positive performance of the Underlying.

The redemption of the product depends on the Final Fixing Value of the Underlying. The Redemption Method is as follows.

- If the price of the Underlying is quoted above the Knock-in Level at any time during the Knock-in Level Observation Period: the product is repaid in the amount of the Denomination
- If the price of the Underlying is quoted at or below the Knock-in Level at any time during the Knock-in Level Observation Period and
  - if the Final Fixing Value of the Underlying is at or above the Cap Level: the product is repaid in the amount of the Denomination; or
