You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives Ziel dieses Produktes ist es, dem Anleger, die Aussicht auf einen erhöhten Ertrag zu geben bei gleichzeitigem Risiko eines teilweisen oder vollständigen Verlusts des eingesetzten Kapitals. The number of Underlyings to be delivered is defined according to the Ratio (fractions will be paid in cash, no cumulation). In this case, the investor will incur a loss, if the value of the delivered Underlyings on Redemption Date plus the compensation payments (for fractions of the Underlying) is lower than the amount invested by the investor.

A Knock-Out Event occurs when the value of at least one Underlying touches or falls below the Knock-Out Level during the Knock-Out Level Observation Period. The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends). How long should I hold it and can I take money out early?

Recommended holding period: 23/01/2026 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product overthe-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so.
