You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type Uncertificated securities issued in the form intermediated Securities (Bucheffekten), governed by Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. It is primarily aimed at investors who expect a decreasing volatility of the Underlyings and expect the value of the product at maturity will be at the same level or above the respective Cap Level. The investor purchases the product at a discount and does not benefit if the closing price of the Underlyings is above the corresponding Cap Level.

The amount of the repayment depends on the performance of the Underlyings on the Final Fixing Date. In detail:

- If no Knock-in Event occurs: The product is repaid in the amount of the Denomination; or
- If a Knock-in Event occurs and
 - if the Final Fixing Value of each Underlying is at or above its Cap Level: The product is repaid in the amount of the Denomination; or
 - if the Final Fixing Value of at least one Underlying its Cap Level: The product is repaid by delivering the Underlying with the worst performance (between the Initial Fixing Date and the Final Fixing Date), i.e. the redemption amount is linked to the negative performance of the Underlying with the worst performance (between the Initial Fixing Date and the Final Fixing Date). The number of Underlyings to be delivered is defined according to the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the value of the delivered Underlying on the Redemption Date, including the compensation payments (for fractions of the Underlying), is lower than the amount invested by the investor.

A Knock-in Event occurs when the value of at least touches or falls below the Knock-in Level during the Knock-in Level Observation Period.

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).

What happens if Zürcher Kantonalbank is unable to pay out?

The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
