Key elements of the product

This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. The product is considered as transparent and has predominant one-off interest (IUP). The Coupon of 5.2219% p.a. is divided into a premium payment of 4.6597% p.a. and an interest payment of 0.5622% p.a.. The interest payment is subject to income tax and is determined in compliance with the 'modifizierte
