The Coupon of 7.6517% p.a. is divided into a premium payment of 3.5019% p.a. and an interest payment of 4.1498% p.a.. The interest payment is subject to income tax at the time of payment. The Swiss withholding tax is not levied. ### 4. Additional Terms
