You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. It allows the investor to receive a cash payment in the Product Currency at least equal to the Capital Protection Amount on the Redemption Date, as well as a participation (see below Upside Participation Rate) in the positive performance of the Underlying. Due to the Cap Level, the redemption amount is limited to the Maximum Redemption Amount. The redemption of the product depends on the Final Fixing Value of the Underlying. The redemption modalities are as follows:
