You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. It allows the investor to receive a cash payment in the Product Currency at least equal to the Capital Protection Amount on the Redemption Date, as well as a participation (see below Upside Participation Rate) in the positive performance of the Basket. The redemption of the product depends on the Basket Value on Final Fixing Date. The redemption modalities are as follows:

- If the Basket Value on Final Fixing Date at or below the Exercise Price, the investor receives a redemption amount on the Redemption Date that corresponds to the Capital Protection.
- If the Basket Value on Final Fixing Date is above the Exercise Price, the investor receives a redemption amount on the Redemption Date corresponding to the Denomination multiplied by the Basket Value on Final Fixing Date divided by the Exercise Price and multiplied by the Upside Participation Rate. I.e. the redemption amount is under-proportionally linked to the positive performance of the Underlying.

The product is currency hedged, i.e. the calculation of the repayment does not depend on exchange rate fluctuations between the product currency and the currency of the underlying (quanto style).

The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.
