This product is a combined investment instrument that essentially consists of a fixed income security and the sale of a down-and-in put option. This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise

slightly. If no Knock-in Event occurs, the investor receives a cash redemption in the amount of the Denomination. The product is considered as transparent and has predominant one-off interest (IUP). The Coupon of 6.80% p.a. is divided into a premium payment of 6.2231% p.a. and an interest payment of 0.5769% p.a.. The interest payment is subject to income tax and is determined in compliance with the 'modifizierte Differenzbesteuerung' tax rule based on the ESTV Bondfloor Pricing method.
