If a Knock-in Event occurs and if the Final Fixing Value of the Underlying is below the Cap Level , the investor receives a cash repayment corresponding to the Denomination divided by the Cap Level and multiplied by the Final Fixing Value. #### 3. Material Risks for Investors
