Purpose This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The objective of this Product is to provide the Investor with an entitlement to returns in the form of Coupon Payments which are independent of the performance of the Underlyings (each an 'Underlying' and together the 'Underlyings', see table below). The Coupon Payments are equal to 0.50% p.a. of the Denomination and are payable on the Coupon Dates. The product offers the investor upside participation on the positive performance of the Basket.

Repayment on maturity

If the investor holds the product until the Redemption Date, the maximum amount it may receive is the redemption amount plus the sum of the coupon amounts. The investor participates in the positive performance of the Basket.

By investing in the product, the investor will receive a redemption amount equal to 100.00% of the Denomination plus the Upside participation (170.00%) on the Redemption Date, provided that the Basket performs favourably for the investor. If the Underlyings perform unfavourably for the investor, the redemption amount may be lower. In detail:

- If no Knock-in Event occurs: The product is redeemed at an amount equal to the maximum of the Denomination, or the Denomination multiplied by 170.00% of the positive performance of the Basket (between Initial Fixing Date and Final Fixing Date). I.e. the redemption is overproportionately linked to the positive performance of the Basket. The positive participation is unlimited; or
- If a Knock-in Event occurs: The product is repaid at an amount equal to the Denomination multiplied by the Final Fixing Value of the Underlying with the worst performance (between the Initial Fixing Date and the Final Fixing Date) divided by its Cap Level, i.e. the redemption amount is linked to the negative performance of the Underlying with the worst performance. In addition, any positive performance of the Basket (between Initial Fixing Date and Final Fixing Date) multiplied by the Upside participation rate is paid out in cash. In such a case, the investor suffers a loss if the redemption amount, including the Coupon Payments, is lower than the amount invested by the investor.

A Knock-in Event occurs when the value of at least one Underlying touches or falls below the Knock-in Level during the Knock-in Level Observation Period.

If the investor purchases the product during the term, he does not pay any additional accrued interest because this is included in the trading price ("dirty price"). The investor has no entitlements arising from the underlyings and/or components of the underlying (e.g. voting rights and dividends).

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

According to the product terms and conditions, in case of an extraordinary event adjustments may be made to the product and the Issuer may terminate the product early. These events are specified in the product terms and conditions, and mainly relate to the Underlyings, the product and the Issuer. In such cases, the redemption amount may be significantly lower than the purchase price. The Investor should therefore be prepared to accept a partial or total loss of his investments. Target Market The product is aimed at Retail investors who are pursuing the objective of general asset accumulation and optimisation and have a short-term investment horizon. This product is intended for investors with extended knowledge and/or experience of financial products. The investor may bear losses up to a total loss of the invested capital and places no value on capital protection.

What are the risks and what could I get in return?

Recommended holding period: 02/07/2027 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
