You are about to purchase a product that is not simple and may be difficult to understand.

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to grant the investor a specific entitlement at predefined conditions. The product has a fixed term and matures on the Redemption Date. The redemption modalities are as follows:

- If the Final Fixing Value of the Underlying is below the Exercise Price: The redemption of the product takes place via delivery of the Underlying i.e. the redemption is linked to the negative performance of the Underlying. The number of Underlyings to be delivered per Denomination is defined according to the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the sum of the value of the delivered Underlying on the Redemption Date plus the compensation payments (for fractions of the Underlying) is lower than the amount invested by the investor.
- If the Final Fixing Value of the Underlying is at the same level or above the Exercise Price: The product is redeemed at an amount equal to the Denomination multiplied by the Final Fixing Value divided by the Exercise Price multiplied by the Upside Participation Rate, i.e. the redemption amount is overproportionately linked to the positive performance of the Underlying. The positive participation is unlimited.

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends).

What happens if Zürcher Kantonalbank is unable to pay out?

In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. How long should I hold it and can I take money out early?

Recommended holding period: 08/07/2027 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
