You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives Ziel dieses Produktes ist es, dem Anleger, die Aussicht auf einen erhöhten Ertrag zu geben bei gleichzeitigem Risiko eines teilweisen oder vollständigen Verlusts des eingesetzten Kapitals. Das Produkt richtet sich in erster Linie an Anleger, die eine abnehmende Volatilität der Basiswerte erwarten, und dass der Wert der Basiswerte bei Verfall des Produktes auf gleicher Höhe oder über dem Cap Level liegt. The number of Underlyings to be delivered is defined according to the Ratio (fractions will be paid in cash, no cumulation). In this case, the investor will incur a loss, if the value of the delivered Underlyings on Redemption Date plus the compensation payments (for fractions of the Underlying) is lower than the amount invested by the investor.

A Knock-Out Event occurs when the value of at least one Underlying touches or falls below the Knock-Out Level during the Knock-Out Level Observation Period. Target Market The product is aimed at Retail investors who are pursuing the objective of general asset accumulation and optimisation and have a short-term investment horizon. This product is intended for investors with extended knowledge and/or experience of financial products. The investor may bear losses up to a total loss of the invested capital and places no value on capital protection.

How long should I hold it and can I take money out early?

Recommended holding period: 03/06/2027 (maturity) The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
