If the Final Fixing Value is below the Cap Level, the performance is equal to the Maximum Yield (0.426111%). If, on the other hand, the Final Fixing Value is at the same level or above the Cap Level, the performance of the product is inverse to that of the Underlying. The discount reduces the negative performance of the product accordingly.

a ZKB Discount Certificate is limited to the difference between the purchase price and the redemption amount according to "Redemption Method" if the Final Fixing Value is at or above the Cap Level. The redemption amount can be significantly lower than the purchase price.
