You are about to purchase a product that is not simple and may be difficult to understand.

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The objective of this product is to offer the investor the prospect of an increased return, accompanied by the risk of a partial or total loss of the capital invested. If the performance of the Underlying is positive, the investor receives the Maximum amount in the product currency. The product has a fixed maturity and

Repayment of the product is dependent on the performance of the Underlying on the Final Fixing Date. The repayment terms are as follows:

- If the Final Fixing Value of the Underlying is below the Cap Level. The product is repaid in the amount of the Denomination plus the maximum possible product performance in the product currency; or
