**You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type** This product is a debt security in the form of an uncertificated security issued under Swiss law.

**Term** The product has a fixed term and matures on the Redemption Date.

**Objectives** The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. It is primarily aimed at investors who expect a decreasing volatility of the Underlying and expect the value of the product at maturity will be at the same level or above the Cap Level. The investor purchases the product at a discount and does not benefit if the closing price of the Underlying is above the Cap Level. The amount of the repayment depends on the performance of the Underlying on the Final Fixing Date. In detail:

- If the Final Fixing Value of the Underlying is at or above the Cap Level: The product is repaid in the amount of the Cap Level; or
- If the Final Fixing Value of the Underlying is below the Cap Level: The product is repaid by delivering the Underlying, i.e. the redemption amount is linked to the negative performance of the Underlying. The number of Underlyings to be delivered is defined according to the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the value of the delivered Underlying on the Redemption Date, including the compensation payments (for fractions of the Underlying), is lower than the amount invested by the investor.

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends).

#### What happens if Zürcher Kantonalbank is unable to pay out?

**Recommended holding period: 16/02/2026 (maturity)** The objective of this product is to provide the investor with the entitlement described above under "What is this product?" provided the product is held to maturity.

The investor has the option to redeem the product by selling the product through the stock exchange on which the product is listed or by selling the product over-the-counter to the product manufacturer. The product manufacturer will endeavor to publish bid and ask prices for the product under normal market conditions on each banking day, but is not legally required to do so. If you sell the Product before the end of the recommended holding period, the amount you then receive may be less than the amount you would otherwise have received, even substantially.
