You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested. It is primarily aimed at investors who expect a decreasing volatility of the Underlying and expect the value of the product at maturity will be at the same level or above the Cap Level. The investor purchases the product at a discount and does not benefit if the closing price of the Underlying is above the Cap Level. The amount of the repayment depends on the performance of the Underlying on the Final Fixing Date. In detail:

- If the Final Fixing Value of the Underlying is at or above the Cap Level: The product is repaid in the amount of the Denomination; or
- If the Final Fixing Value of the Underlying is below the Cap Level: The product is repaid by delivering the Underlying, i.e. the redemption amount is linked to the negative performance of the Underlying. The number of Underlyings to be delivered per Denomination is defined according to the Ratio. Remaining fractions are not delivered but settled in cash. In such a case, the investor suffers a loss if the value of the delivered Underlying on the Redemption Date, including the compensation payments (for fractions of the Underlying), is lower than the amount invested by the investor.

The investor has no entitlements arising from the underlying and/or components of the underlying (e.g. voting rights and dividends).

The risk and return profile of the product described above will change if the product is sold before the Redemption Date.

What happens if Zürcher Kantonalbank is unable to pay out?

In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. The product manufacturer endeavors to publish bid prices for the product under normal market conditions on each banking day, but is not legally obliged to do so.
