down-and-in put option. This allows the investor to benefit from the current volatility of the Underlyings. An above-average return is achieved when prices fall slightly, stagnate or rise slightly. The product is considered as transparent and has predominant one-off interest (IUP). The Coupon of 11.60% p.a. is divided into a premium payment of 11.4063% p.a. and an interest payment of 0.1937% p.a.. If a Knock-in Event occurs and if the Final Fixing Value of the Underlying is below the Cap Level , the investor receives a cash repayment corresponding to the Denomination divided by the Cap Level and multiplied by the Final Fixing Value of the worst performing Underlying. Therefore, the investor may suffer a partial or total loss. The acquisition price is 100.00% of the Initial Fixing Value. This negative performance is reduced by the guaranteed Coupons paid out during the term.
