You are about to purchase a product that is not simple and may be difficult to understand.

### What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The objective of this Product is to provide the Investor with an entitlement to returns in the form of a Coupon Payment which is independent of the performance of the Underlyings (each an 'Underlying' and together the 'Underlyings', see table below). The Coupon Payment is equal to 12.5421% p.a. of the Denomination and is payable on the Coupon Date.

#### **Repayment on maturity**
