The product is considered as transparent and has predominant one-off interest (IUP). The Coupon of 11.1571% p.a. is divided into a premium payment of 10.9971% p.a. and an interest payment of 0.16% p.a.. The option premium part qualifies as capital gain and is not subject to Swiss income tax for private investors with Swiss tax domicile. The interest payment is subject to income tax and is determined in compliance with the 'modifizierte Differenzbesteuerung' tax rule based on the ESTV Bondfloor Pricing method.
