#### What is this product?

Type This product is a debt security in the form of an uncertificated security issued under Swiss law.

Term The product has a fixed term and matures on the Redemption Date.

Objectives The aim of this product is to give the investor the prospect of an increased return with the simultaneous risk of a partial or complete loss of the capital invested.
